Dear Friends of the Foundation,

As I draft this letter Camp Deerwood would be in the final week of the second half of the season with campers busy finishing up their shop projects, rehearsing their songs and lines for our final production in the new theater and practicing their skills with kayaking and canoeing. However, this year the grass is growing strong in the areas usually worn bare from use, the dining room (Toots Shor) and all the camper cabins are still shuttered from the winter before. For the first time since 1944, the Stone Reservoir has remained empty. The bell has remained silent. Our neighbors have remarked that they miss hearing it! "It just doesn't seem right" they say.

It isn't "right" that a summer without Deerwood has affected so many young men. A summer at Deerwood is much more than just fun and recreation. It is a period of intense growth: spiritually, emotionally, physically and of inner confidence. The microcosm of Camp Deerwood is a tremendously supportive environment where staff and campers interact as equals, where everyone can be a role-model and where challenging ones' self is encouraged, successes are applauded, and failures respected. In short, life at Camp Deerwood is wholesome!

Camp Deerwood is the caldron in which all of us grow and this is the experience the Deerwood Foundation wishes less fortunate young boys can grow from. Two of the missions of the Foundation are: • provide financial help to families that would otherwise not be able to afford to send their sons, and • support young men with leadership potential to be counselors with the Tree Talk Fellowship. Camp Deerwood is now in its third generation of leadership and it has 4<sup>th</sup> generation campers. The Deerwood tradition is strong! The Foundation supports young men of less privileged backgrounds so that we all may grow together. To this end, we have established connections with organizations with intimate knowledge of young men that will gain from several summers at Camp Deerwood. Some of these organizations work with inner city and itinerant farming communities and the boys we support from these organizations not only grow with us they contribute greatly by sharing their life experiences with the greater community. The greater the diversity of our summer community the better we all are for our summer experiences!

This summer of covid-19, with Camp closed, our 24 Deerwood Foundation Campers spent the summer at home instead of on the shores of Squam Lake. As has happened for the last 26 years, the Foundation had allocated financial assistance to these families. (For an understanding of how these funds were used please read the report on page 3 of this newsletter.) Every fall the Foundation uses this Annual Newsletter as the means to report our successes of the past year, formally acknowledge our donors, and to appeal for your continued donations. Our need for support continues as we feel strongly that our mission is important and will continue to have a positive impact on the lives of each of us. The Deerwood Family is special in many ways. To all our supportive community we send our sincere thanks for your continued support. We know there are many worthy organizations requesting your financial support. May the year 2021 see all of us not wearing face masks and Camp Deerwood once again busy with the activities of happy campers and staff and the bell ringing again.

## A word from Tim Caffrey

Just a year ago this Labor Day Weekend, many of us gathered at Camp to celebrate Deerwood's 75<sup>th</sup> summer. A terrific weekend it was, where the common connection and love for Deerwood that we all share was on full display. The juxtaposition of this event with our current reality and the cancellation of Camp could not be starker, but as we learned on rain-soaked trips, the bad weather will eventually pass.

Thank you all for your generous donations! As you will read in greater detail on page three, the Foundation used the funds that are normally spent on current annual camperships to prepay camperships over the next 15 years – approximately two camperships per year. This action provided cash flow to Camp to help with fixed expenses during a non-revenue year, while simultaneously staying true to our mission of helping boys afford and attend camp.

I would also like to express my gratitude to our retiring Board members; Bob Calhoun, Bill Lee and Graham Shafer. Their generous gifts of time, financial support, wisdom and friendship has served the Foundation well. The Foundation Board has filled their shoes with many recognizable Deerwood names, JB Boynton, Don Brown, Andy Smith, Dan Ragsdale and Bruce Wilhelm.

In early June, I was on an email chain with some Deerwood alums expressing their sadness that Camp was not going to open this year; their gratitude for the Thomsen family and their appreciation of Camp. For me, one email, from Derek Martin captured both the timeless lessons of Deerwood and the emotion that all of us who love Deerwood and the Thomsens were feeling.

Derek writes:

"There are so many important things in life that I learned from Deerwood and the Thomsens.

Waking with the sun, cleaning and chores, hygiene and maintenance, the importance of correspondence, the balance of a schedule and free time, the value of eating with friends, crafting something from raw material, making time for both hard play and spiritual reflection. Reading with one another, embracing spontaneity, discovering awe and serenity on the water and in the mountains. Taking chances and being brave. Saying I'm sorry and owning up to it when we screw up (I've had to do that one a lot).

We all have Buck and Tommy and Len, Peter and Lorne, JT and Lar-Lar, TT and DT, and all the wonderful sisters, mothers, wives and daughters of the Deerwood family to thank for so very much.

I know that so many of our Deerwood brethren will be missing Camp this summer. I can hear Tommy and Len saying "Welcome home." Man I miss the grip of Tommy's extended hand. And Len telling me to check myself, with a sly glance.

## How the Foundation's 2020 Scholarship Funds were expended this year.

Due to the havoc that our Covid-19 summer caused when it was decided not to open Camp this summer, the Deerwood Foundation immediately received quite a few calls and emails from the Deerwood community inquiring if there was something the Foundation could do to help Camp Deerwood. The Board of Directors worked swiftly to draft a resolution that made the following possible:

This past winter The Foundation's Scholarship Committee voted to award \$125,000 toward camperships for the 2020 summer. This payment was scheduled to be transferred to Deerwood on June 1st to cover the Camp fees for 24 Deerwood boys, including five full-time campers, thus representing 29 half-session Deerwood spots. By the end of June, the Foundation Board of Directors passed a resolution to still award the 2020 campership money to Deerwood as a pre-payment. The resolution stipulates that Deerwood will pay back the funds in the form of future tuition discounts or camperships, most likely two each year for the next 12 to 15 years. Please be assured that the funds donated in support of this year's campers have been put to good use and will be paid forward, allowing boys next year and in the future to attend camp when they might otherwise not be able to afford it. This pre-payment has also been immensely helpful towards ensuring that Deerwood is able to meet its unavoidable 2020 expenses including maintenance, taxes and insurance. It has also allowed Deerwood to carry on traditions that help retain campers, such as mailing out 3rd-year fleeces and 6-year blankets. Thanks in part to this resolution, Deerwood will be in great shape and ready to welcome campers in 2021!

# Campership Report 2020

We had 24 campers scheduled for this past summer, five of whom were full time, giving us 29 single session equivalents. Five full session campers, who are at least second or third year returnees and often more, is a high number for us and speaks to Camp's enduring impact. We counsel new families and campers that we want to support them for many years.

Full summer: 5 campers; 1st session: 11campers; 2nd session: 8 campers Foundation campers - years at Camp going into the summer of 2020

7 years: one camper

- 4 years: two campers
- 3 years: one camper
- 2 years: three campers
- 1 years: nine campers
- New: 8 campers

In the Summer of 2021 the Foundation will support most, if not all, these same Campers.



## Tree Talk Fellowship 2020

This was to be our first year of the Tree Talk Fellowship and we awarded two! Both recipients were to be counselors this summer and had signed contracts with Camp Deerwood before Camp was canceled. The Board of Directors decided to honor our commitment and David Levy and Heath Carignan will each receive \$500 of their post high school education bill paid directly by the Deerwood Foundation.

Jay "JB" Boynton has been involved with Deerwood for many years. His father, John Boynton, was a camper and a married counselor at Deerwood and JB's mother, Diane Boynton, worked in the Ty office. JB grew up at Deerwood and was captain of the Grays in his final year as a camper. The history he has with Deerwood and the Thomsen family provide the passion and dedication the Foundation looks for in our board members. Jay's Dad was one of the first Foundation

#### DON BROWN

Don Brown first arrived in Holderness in June of 1973 where he stayed in Savoy, was awarded the Happiest Boy trophy and cemented a lifelong love for all that is Camp Deerwood. Only a camper for two years, Don, better known around Camp as Business Don or BusyD, grew up in Chagrin Falls, Ohio where he wrestled and played on the soccer team. After graduating



from Northwestern University, Don moved to Boulder, Colorado where he attended law school and practiced water and land use law for 7 years before venturing into the internet start-up world. Three ventures later, he founded Secondary Interactive which eventually became Optimal Blue, the leading marketplace platform for the secondary mortgage market.

Don is married to Karen and the two have lived in Louisville, Colorado for the past 25 years. They have two children. Donny lives in Columbus, Ohio with his wife Sarah. Donny is a Deerwood veteran having spent 10 summers at Camp, winning Senior Deerwood in his last year as a camper and then staying on to be a counselor for several seasons. Like so many educators and coaches in the Deerwood family, Dan discovered his passion for working with young people under the thoughtful and expert guidance of the Thomsen family. Dan has spent the majority of his professional life in education, most recently as a middle school English and history teacher at a New York City boys' school. The particulars of teaching tennis, creating a Parents' Weekend musical, or leading trips differ from the academic classroom, but the foundation of Dan's educational philosophy is a direct result of his years at Deerwood. The Thomsens have long championed relational teaching, the importance of fun (though, never at another's expense), and an abiding belief that each boy deserves to be known and loved for who he is. #### BRUCE WILHELM



As a 30-year veteran of working in education, Bruce Wilhelm has always strived to create an environment and tone in school that resembles what makes Deerwood so special and magical. Respect, responsibility, accountability, inclusion, kindness, and fun are those ideals. Bruce, who has just started his own educational consulting business, ThinkWrite, worked at Deerwood for 15 summers in the office, on the tennis courts, and on trips. His wife, Tracy, worked in the office for a number of summers, and his three sons, Luke (25), Henry (23), and Gregory (16) have all spent multiple summers as campers, and some as counselors. Quite simply, because of the Thomsen family and the people who choose to spend their summers there, and the child-centered mission of the Camp, Deerwood is the family's favorite place on earth.
